The school year 2022-2023, Rainbow Schools, announced its policy for free and reduced-price meals served under the Child Care Food Program to children meeting the approved eligibility criteria.

The following household size and income criteria will be used for determining eligibility for free and reduced price meals:

Children from households whose annual income is at or below the levels shown are eligible for free or reduced-price meals.

Application forms are being provided to all homes of enrolled children with a letter to parents. Additional copies are available at the institution. The information provided on the application is confidential and may be verified at any time during the year by the institution or other program officials. Applications may be submitted at any time during the year.

In certain cases foster children are also eligible for these benefits. If a family has foster children living with them and wishes to apply for such meals for them, it should contact the institution.

Under the provisions of the policy, Rainbow School's Food Service Director will review applications and determine eligibility. If a parent is dissatisfied with the ruling of the official, he may wish to discuss the decision with the determining official on an informal basis. If he wishes to make a formal appeal, he may make a request either orally or in writing to:

for a hearing to appeal the decision. The policy contains an outline of the hearing procedure. If a family member becomes unemployed or if family size changes, the family should contact the institution to file a new application. Such changes may make the children of the family eligible for reduced-price meals or for additional benefits such as free meals if the family income falls at or below the levels shown.

In accordance with federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, this institution is prohibited from discriminating on the basis of race, color, national origin, sex (including gender identity and sexual orientation), disability, age, or reprisal or retaliation for prior civil rights activity.
